### **Committee Reports**

**Treasury – Tanya Georgiev:** Financial information is available upon request to members only.

**City Liaison – John Robinson:** John Robinson has reached out to the city about lining the fields and cutouts needed for goal storage. The city of Deltona needs to be alerted of all club activities. John Robinson will be creating a calendar to be shared with the city.

**Financial Aid/Scholarship – Jesse Phillips:** Jesse Phillips has reached out to FYSA regarding the equipment scholarship and player scholarship funds. The

applications are scheduled to be reviewed and voted on by a panel this week. Scholarships should be received within 60 days.

**Fields Manager – Marco Roldan/Billy Barry:** Marco Roldan will be replacing old locks on goals and ordering materials for goal repairs. All goal locks and wheels will need to be maintained monthly. All fields to be lined by the city prior to the Academy's first game on Friday, February 22<sup>nd</sup>.

**Scheduler – Billy Barry:** Billy Barry will be entering blackout dates for travel this week.

**Travel Registrar – Andrea Velazquez:** There have been 12 new registrations for the spring season. This does not include 4 academy players that will be transferring to travel. A team manager meeting will be held on Thursday, February 21<sup>st</sup> at 7pm at Dewey O'Boster Park. The registration links on the website will be removed. The link will only be provided to players after tryouts. Any player interested in joining travel will contact John Robinson.

**Travel Bookkeeper – Michelle Ayala:** No report.

**Academy Registrar – Josie Snyder:** Junior Academy – 64 players registered, down 32% from last year; Senior Academy – 136 players registered, down 20% from last year. Cutoff for senior academy registration will be February 22<sup>nd</sup>. Bob Uehlein to post information to club website and club social media accounts.

**Academy Bookkeeper – Josie Snyder:** Junior Academy – 9 payments are currently due; Senior Academy – 4 payments are currently due.

**DOS – Orlando De La Torre:** This year there were 48 registered for Winter Camp. Although registrations were down at least 50% from last year, feedback from parents has been excellent. We need to begin marketing well before camps to increase registrations. Orlando De La Torre will be creating a tournament committee. Tournament to be held at Dewey in August.

**DOC – Rolando Rivero:** All coaches, with one exception, are D licensed or better. Basic equipment is needed for new coaches and Junior Academy. Orlando De La Torre will be purchasing new equipment this week. John Robinson will be creating an equipment contract to ensure all equipment is turned in after each season.

**Jr. Academy Director – Orlando de la Torre:** Junior Academy begins this week.

**Sr. Academy Director – Billy Barry:** No report.

**Website/Public Relations – Bob Uehlein:** The club Twitter account has been recaptured. Bob Uehlein will be boosting the last day of registration reminder on Facebook.

**New Business:**
